3. The prescribe rate of interest for the third advance shall be 2% above the normal rate of interest on marriage /Conveyance /Computer advance.
4. It has also been decided to fix the rate of interest at 8.1% ( Eight point One Percent) per annum on deposits in the General Provident Fund and other similar funds w.e.f 1.4. 2016 to 30.6.2016. This rate of interest will remain in force during the financial year 2016-2017.
