 2. Rs. 1/- per page as Photostat Charges.
 3. Court fee as per actual.
 4. Rs. 1000/- per case payable as miscellaneous expenses.
 5. Any other expenses are payable when the same are specifically mentioned by indicating the amount actually spent.
 6. No clerkage is payable separately.
 7. No junior Counsel fee is payable separately.
2. It is also advised that in any case Board and Corporation do not pay from the department's budget, they can look after their expenditure on their own.




