I am directed to invite your attention to the subject noted above and to intimate that in the last few weeks a number of CWPs have been put up to the Chief Secretary, Haryana where Hon'ble High Court had issued specific directions to the Chief Secretary, to either take certain action or to file an affidavit under his own signatures. In most of these cases the order of the Hon'ble High Court was more than 3 months old. Neither copy of the order had been put up nor any affidavit had been prepared and put up in such cases. In certain cases even the date of filing affidavit had passed and even then the case had not been put up to the Chief Secretary.

2. This is a highly unsatisfactory state of affairs and has been viewed seriously. Accordingly, you are requested that in future, any case where specific directions have been issued to the Chief Secretary should be immediately sent as a fresh receipt for information and perusal of the Chief Secretary in the matters where he is personally required to file an affidavit or take certain specific action to comply with High Court orders. It is also to be ensured that matter is discussed with the CS & AD shall put up draft reply as per discussion.

3. These instructions may please be brought to the notice of all concerned for strict compliance.
