ORDER

After considering the options submitted by all concerned, the following Clerks of Sub-Offices of Food and Supplies Department, Haryana are hereby designated/promoted as Sub-Inspector, Food and Supplies, in the pay band of Rs. 5200-20200+1900 G.P. with immediate effect and posted at the places indicated against their names against vacancy :-

2. It is further made clear that promotion of the above Clerks is being made on their option, so after joining to the post of Sub Inspector, their lien on the post of Clerk will be terminated automatically.
3. The promotion of all the above officials is without prejudice to the final decision in the disciplinary proceeding under rule 7 pending against Sh. Shabbir Ahmed, Clerk posted at Mewat.
4. They will have to deposit a security of Rs. 500/- or more if later on so required. They will deposit in lumpsum of Rs. 250/- immediately before joining the post and the remaining Rs. 250/- in monthly installments not less than Rs. 12/- respectively till the security amount is completed. Further they will have to fill up a surety bond of Rs. 5000/-.
5. Certified that they had not been promoted as Sub Inspector, Food and Supplies, they would have continued to officiate as Clerks.
6. The inter-se seniority of the above officials to the post of Sub Inspector will be fixed in accordance with the Haryana Food & Supplies Department Sub Offices (Group-C) Service Rules, 1982 and as per Govt. instructions.
7. It is necessary to give them training in Circle offices/centers by the respective DFSCs for three months about the work being dealt within the department. The training schedule in various subjects will be as follows:-

8. They will be on probation for a period of one year and will be governed by the Rule 10 of the Haryana Food & Supplies Department Sub Offices (Group-C) Service Rules, 1982.
