**Subject:- Variety-wise recording of Paddy arrival and procurement during
Kharif Marketing Season 2017.**

Reference on the subject cited above.

2. As you are aware that Kharif Marketing Season 2017 is going to start from 1st October, 2017. Further the State Government has also made the request to Government of India for preponement of season from 25th September, 2017. If the preponement is allowed by Government of India than the Government procurement will start from 25th September. At this time the arrival of PB 1509 variety is also at its peak. There are chances that the arhtias in connivance with the rice millers will record this paddy in Government account by making the difference of payment above MSP to the farmers. This variety is Basmati like variety which have low outturn ratio upto 10 kg. in comparison to the required outturn ratio of Grade-A paddy i.e. 67%. This will not only cause a great loss to the State exchequer but will also effect the market rates of PB 1509 which are at present running between Rs. 2200 to 2500 per quintal. On the other hand this will also effect the market fee recovery because the fee in this case will be paid on MSP. This issue was discussed at length in the review meeting for paddy procurement with Hon'ble Chief Minister, Agriculture Minister and Food Minister and it was decided that variety-wise paddy shall be recorded in H-register of Market Committee and Kachcha Arhtias.


In this regard the Additional Chief Secretary to Govt. Haryana Food, Civil Supplies and Consumer Affairs Department have also given directions to all the Deputy Commissioners in the video conference held on 20-09-2017.

Therefore, you are requested to issue necessary directions to all the Secretaries Market Committees and Kachcha Arhtias to record the paddy variety-wise


